Representation to the European Women Lobby (EWL) 2014-2015

Context:

Amélie Leclercq & Sylvaine Boussuard le Cren elected as BPW Europe's representative and alternate representatives to the EWL at the BPW Europe's presidents meeting in May 2013. Their official term start in October 2014 after the EWL General Assembly.

In May 2014, a new Secretary General was recruited: Joanna Maycock with 20 years' professional experience in senior leadership and governance positions in NGOs. She brings new points of views and and attention to governance and involvement of the members.

EWL was created in 1995 and has a program of monthly thematic events in 2015 to mark its 20th anniversary.

EWL is currently in the process to determine its objectives, priorities and means of actions for 2016-2020.



Activities of your representatives



9 July 2014, Sylvaine represented BPW Europe at a EWL event organized at the European Parliament "no more excuses, gender equality after the EU elections". A report was sent to the ECC.

ON 20-21 September 2014 Amélie and Sylvaine participated in the "Second European Citizen Summit" organized in Brussels by a Social Platform of NGOs of which EWL is one. Important to have more members participating as the only organisations with a feminist approach present then where the EWL and BPW Europe. The other members of the social platform objectives were: environment, education and culture, social insertion, health. It was striking to see how they had all forgotten to include gender mainstreaming in their topics.

On 10-12 October 2014 Amélie participated in the EWL General Assembly in Lisbon with Solveig Staffas who was finishing her term. After being elected to the EWL Board of administration, participation in the "strategic thinking" workshops. Asked by the Secretariat General to be member of the steering committee of a new project on female social

entrepreneurship. The General Assembly was the starting point of a year-long exercise to determine the objectives and actions for the EWL 2016-2021. Viviane Teteilbaum, (BE) was reelected as president of the EWL.

In November 2014 and January 2015, Amélie participated in meetings of the steering committee of WEStart, Female Social Entrepreneurship. Calls for candidatures for positions of national consultants had been sent out to all BPW Europe members in November 2014 and BPW members from France and Ireland contacted Amélie for more information and sent out their candidatures. The choice of the national consultants was done in January 2015 by the Secretariat General of the EWL.

Information regarding another short term position of consultant to support the start of a EWL Central Eastern and South Eastern Task Force was also disseminated in January to the presidents of federations and clubs in the relevant countries.

In January 2015 Amélie participated in a EWL meeting in Brussels to assess and comment on a document published by the secretariat general in December 2014 as basis for discussion for the 2015-2021 strategy. One of the issues under discussion is how the secretary general interact with the EWL members, to allow members to feel more ownership of EWL.

On 24th February 2015, EWL event to present the "crack in the ceiling" report on women on boards. Karin Raguin, European Coordinator was one of the speaker. Guiseppa Bombaci, Amélie Leclercq, Miette Dechelle were present at that event which was also a good networking opportunity.

On 20 February 2015 – organisation of a workshop on "visual communication" by BPW Brussels. EWL agreed to let one of the member of the secretariat general, Elvira Buijink to share her experience with BPW Brussels and Soroptimist members. This workshop allowed to provide a small financial support to EWL work and to organise an activity in common with Soroptimist.
